His landmark appellate victories include *Cantolino v Danner* 96 N.Y.2d 391 754 N.E.2d 164 (2001) [Where the standard for favorable determinations as predicates for malicious prosecution claims was redefined]; *In re Brooklyn Resources Recovery, Inc.* 309 A.D.2d 931 766 N.Y.S.2d 121 (2nd dept. 2003) [Where a general release was held to bar recovery of a shareholder loan in the context of a corporate dissolution proceeding.]; *In re Ciraolo* 37 A.D.3d 461 829 N.Y.S.2d 611 (2nd Dept. 2005) [Where the inadmissibility of an uncompleted deposition was affirmed.] *Spataro v. Hirschhorn* 40 A.D.3d 1070 837 N.Y.S.2d 258 (2nd Dept 2007) [Where vagueness precluded enforcement of physicians' arbitration agreement.]

Mr. Genovesi has been designated as a New York Super Lawyer in Business Litigation since 2021, a distinction earned by only 5% of the lawyers in the NY metro area.
