### **Contempt Litigation**

In 2023, Amy Marion won a civil contempt hearing and obtained attorney's fees for her client in a contentious commercial litigation matter and in 2025 she successfully defended a client in a lengthy contempt hearing and avoided jail time for the client.

### **Religious Corporation Disputes**

Abrams Fensterman has successfully handled litigation disputes involving religious corporations, safeguarding clients' interests in complex legal contexts. In 2021, Amy Marion won a trial for her clients involved in a contentious religious corporation dispute and quite recently, in 2026, she won a hearing in

another case, getting the entire case against her clients fully dismissed.
