ABRAMS FENSTERMAN SCORES MAJOR WIN IN COMPLEX OPMC CASE

New York City / Lake Success, NY, June 9, 2015: Abrams, Fensterman, Fensterman, Fisman, Formato, Ferrara & Wolf, LLP recently obtained a substantial victory for a physician-client in a complex New York State Department of Health, Office of Professional Medical Conduct ("OPMC") case. The case was tried by Michael S. Kelton, Partner-Director of the firm's OPMC Practice, and Associate Jordan Fensterman.

In Matter of M.H., M.D., Dr. H, an emergency room physician, had been charged by OPMC with 21 specifications of professional misconduct, alleging negligence on more than one occasion (5 specifications), gross negligence (5 specifications), incompetence on more than one occasion (5 specifications), gross incompetence (5 specifications) and improper record keeping (1 specification). These charges arose out of Dr. H's care and treatment of 5 patients in the emergency room of a regional hospital from December 2011 through June 2012.

When the cases were initially sent to our emergency medicine expert for his review, the expert determined that at least 3 of the cases were "indefensible". Undeterred, Mr. Kelton and Mr. Fensterman devised a trial strategy that focused on challenging the testimony of OPMC's witnesses, including several nurses, a fellow treating physician and OPMC's own emergency medicine expert.

Over several hearing days, through meticulous preparation and skillful cross-examination, Mr. Kelton and Mr. Fensterman were able to severely undermine the credibility and reliability of OPMC's witnesses. The OPMC Hearing Committee found numerous instances whereby the testimony given by those witnesses on direct examination was refuted during their cross-examination. The result was that the Hearing Committee absolved Dr. H of every charge against him. OPMC did not appeal the April 17, 2015 decision of the Hearing Committee, which is now final.

In addressing this outcome, Mr. Kelton stated, "In my 35 years of defending physicians in OPMC cases, I can confidently state that such a comprehensive victory, considering the challenges we faced, is almost unprecedented in this forum."
